Martin Heskins

Martin became the General Manager of Medco Registration Solutions in December 2015 upon his retirement from the Law Society where he was the Civil Justice Policy Adviser for 11 years. He subsequently took over the role of Chair of MedCo in December 2016.

He has an extensive background in civil litigation having spent 29 years in practice when he acted for claimants and defendants, including major insurance companies, local authorities and a Police Authority. During his time at the Law Society he was the lead on all civil litigation costs and funding issues, including the Jackson reforms and the Legal Aid Sentencing and Punishment of Offenders Act 2012 (Part 2). As well as facilitating continuing professional development events he also represented the Law Society in major stakeholder negotiations with the Government, Insurers and the Civil Justice Council, including the setup of the Claims Portal.

One of Martin's main aims in his role with Medco is to ensure the system works more effectively, within the policy constraints provided by government, so that unacceptable behaviours are eradicated as soon as possible.

David is the senior partner at Bott & Co.

As well as being a member of the Association of Personal Injury Lawyers (APIL), David also served as the APIL President from April 2011 to April 2012 and sat on APIL's Executive Committee for 12 years.

Caring greatly about the rights of claimants, he has been heavily involved with the RTA Claims Portal via the Project Steering Group and was formally a Director of PortalCo.

He was elected to the executive committee of the Legal Management Section of the Law Society in April 2006 and sat on it until 2012. David later became vice-chairman of the Legal Management Section for two years.

David has sat on the Board of MedCo since May 2015.

Wayne Brannan
